Minutes:

Commissioner Ballard made a motion to accept the April 20, 2020 minutes, as written. Seconded by Commissioner Mere. The motion was put to vote, and approved by the Board. All were in favor. The vote was 5-0. (1)

**Treasurer's Report**: The April treasurers report was presented. At this time, we are 59% through the budget year, received 97% of revenues (including cash brought forward) and spent 54% of expenditures (less reserves). (2) There were no questions or comments.

# Chief's Report:

By Chief Rice-

- Still monitoring COVID 19
- We need to begin talking about the replacement of our Rescue trucks and a new Engine for next budget year
- Washers and Dryers are installed at each station, we moved the gear extractor to Station 1, and are waiting on the new gear extractor to arrive at Station 2
- Paradise Isle Project not sure what is going to happen with that project, so for now we should just plan to purchase a standard Engine. There is a hearing scheduled for June 10, 2020 regarding the project
- Received our ISO report back and our ISO rating has dropped to a 3/3Y rating. Thanked all staff for their assistance during the ISO process
- Congratulated Dillon Bryant as he will be promoted to the Lieutenant's position upon Brian Roberts retirement at the end of May
- The front apron at Station 3 (Slater Road) will be re-paved next week
- Busy with brush fires

Seconded by Commissioner Hoke. The motion was put to vote, and approved by the Board. All were in favor. The vote was 5-0. Commissioner Gatewood said we needed to be working on a plan for Battalion Chief promotion. Chief Rice replied that he feels he could work with the candidate while they were on shift for a few months.
