• 2024/2025 Budget Amendment:

The motion was put to vote, and approved by the Board. The vote was 4-0. (3)

• 2025/2026 Millage Rate:

Commissioner Ballard made a motion to set the Millage Rate for the Fiscal Year 2025/2026 at 3.5 mills. Seconded by Commissioner Gatewood. The motion was put to vote, and approved by the Board. The vote was 4-0. (4)

- Renewal of Legal Counsel Contract:
   Commissioner Ballard asked if we are paying for the attorney to attend virtually? Yes. Commissioner Ballard stated that he does not think an attorney needs to attend the monthly Commission Meetings.
   Commissioner Gatewood made a motion to accept the Contract for Legal Services with Dirk Smits. Seconded by Commissioner Land. The motion was put to vote, and approved by the Board. The vote was 3-1.

- Approval of Contract with Architect for Pondella Road Fire Station:
   Discission ensued regarding the ongoing issue of the billboard still being on the property. Attorney O'Conner stated this issue will be resolved and the billboard will be removed from the property.

   Commissioner Ballard made a motion that the sign be removed from the property. Seconded by Commissioner Gatewood. Commissioner Ballard amended the motion to have the sign removed within 90 days.
   Commissioner Schaible asked the architect if the sign being on the property would prohibit the production of drawings? No. There was no second on the

amended motion. Motion did not pass. Commissioner Ballard made a motion to accept the Contract with the Architect with his recommendation of building a two-story Fire Station. There was not a second, motion did not pass. Commissioner Gatewood made a motion to accept the contract with Architect Christopher J. Lee as written. Seconded by Commissioner Land. The motion was put to vote, and approved by the Board. The vote was 4-0. (6)
