## Swearing in of New Firefighters

Firefighter Brown and Firefighter Hubbard were sworn in by Chief Beecroft

**Public Input:** Debbie Ballard asked for a status update on Robbie Noble. Monique gave an update.

Minutes: Commissioner Gatewood made a motion to accept the February 27, 2023 minutes, as written. Seconded by Commissioner Mere. The motion was put to vote, and approved by the Board. All were in favor. The vote was 5-0. (1)

**Treasurer's Report:** The February Treasurer's Report was presented. At this time, we are 42% through the budget year, received 96% of revenues (including carryover) and spent 40% of expenditures (less reserves). (2) There were no questions or comments.

By Chief Beecroft –

- A Shift did an outstanding job last month with the Structure Fire they had on the day of the meeting
- Annual CERT Picnic was wonderful, and Christi did a fantastic job putting it together
- Battalion Chief Jeremy Dunn recently returned from Tallahassee, where he graduated from the Certified District Manager program
- Avrey is taking the open Fire Inspector position; therefore, we will be advertising for the open position of Administrative Specialist
- Pondella Road Property the parcel has been re-zoned and the sellers have increased the price to 1.2 Million Dollars. This is way overpriced, and not worth that, so we can remove that item from the Agenda. We are still looking at all possibilities for properties within the District
- I am attending a Facilities Planning Seminar later this week
- Several area Chiefs have contacted us about seeing our Performance Review as a model
- FEMA claim Part of our claim has been approved by FEMA and now moving through the process towards payment. The other part of the claim is still in review.

By Chief Manson –

- Engineers and Lieutenants upcoming promotional exam have been posted
- Truck Committee have done a virtual presentation with E-One and now need to meet with Sutphen and Pierce
- Station 2 remodel is going well. Commissioner Hoke asked if we put down vinyl or tile? Tile the same as here at Station 1. He also asked for an update on the fans for the bays? That was just discussed this morning, and they are working on getting that completed, but may hold off at Station 3 for now.
- Brush Fire Season is underway. Brush 1 is currently having the brakes replaced and should be back this week
